With grants from the Brindle Foundation's donor advised fund and the Baby Fund at the Santa Fe Community Foundation, the Friends of the Santa Fe Public Library funded Books & Babies in both English and Spanish/Bilingual. This year-round early childhood reading and activities program serves caretakers and children aged six months to two years. In 2019 eight six-week sessions were held in English, and Spanish/Bilingual sessions were held weekly from June to November. A total of 4,145 participated in English Books & Babies and 3,772 participated in Spanish/Bilingual Books & Babies, a total of 7,917 program participants.

The Friends of the Santa Fe Public Library provides funding for early childhood and youth after-school and summer reading programs at all three Santa Fe Public library branches. in 2019, there were a total of 734 early childhood and youth programs serving 20,163 participants. The six-week summer reading program is held annually at all three branches. To entice children to participate each week, magicians, storytellers, puppeteers & performers put on performances tied to a general reading theme. In 2019, 1,604 children participated in the Summer Reading Program and 1,090 children attended Summer Reading Program performances, for a total of 2,694 total program participants.
